

QUALIFICATIONS AND STANDARDS OF CONDUCT

Miss Rodeo Idaho, Inc. hereinafter referred to as MRII is a private, non-profit corporation providing vision and leadership to Miss Junior Rodeo Idaho, enabling her to represent the state of Idaho and enhance the sport of rodeo and promote our western heritage. MRII hereby declares and establishes the following minimum "Qualifications and Standards of Conduct" that shall be applicable to all title and subtitle holders under contract to MRII and all approved contestants competing for the title of Miss Junior Rodeo Idaho. Establishment of this statement of "Qualifications and Standards of Conduct" by MRII does not nullify, cancel, or preclude existing and additional MRII rules, expectations, or practices now or in the future. MRII reserves the right to amend its rules and operational guidelines by action of the Board of Directors.

CONTESTANT ELIGIBILITY

Each contestant in the MJRI Pageant shall comply with the following effective on the date of competition. Contestants must:

- 1) I was assigned female at birth, and am female.
- 2) Must be age 9 14 by July 1st of the current year.
- 3) Must maintain a 2.5 GPA by most recent report card. Shall supply MRII with a copy of most current report cards.
- 4) Be a resident of the state of Idaho for at least 6 months prior to the pageant and must maintain permanent Idaho residency throughout her MJRI reign.
- 5) It is recommended to be sponsored by an Idaho rodeo committee or a recognized organization such as a service club, chamber of commerce, sheriff's posse, riding club, etc. Sponsors will be recognized on contestant banners, tear sheets, programs, etc.
- 6) May not have been a previous MJRI, be any other state's "Miss Junior Rodeo", currently hold any other state title or any other national pageant, i.e. Idaho Junior High School Rodeo Queen, Idaho Junior Rodeo Association Queen, Miss Idaho Teen or Miss Junior Teen, etc. If the contestant holds another title which has not expired prior to assuming responsibilities as MJRI, she will forfeit that title and will not be allowed to wear any other crown or banner but MJRI if she is chosen as such.
- 7) Shall abide by all rules and regulations of MRII including: MJRI Rule Book and attachments, pageant contestant rules, general rules, written expectations, official communications and documents, and verbal direction from competent authority (National Directors, Judges, and MRII Board of Directors). Concerns shall respectfully be brought to the attention of the involved Director(s), the National Director, Pageant Official or the President in a timely manner.
- 8) Shall have executed and presented all required documents, consents, waivers, contracts and/or agreements presented as conditions or precedents to pageant competition, title or contracted party prior to the receipt of prizes, awards, scholarships, monies, or participation in approved activities.
- 9) I have not engaged in any act, which if made public, would be reasonably likely to cause harm or damage to my reputation or to the goodwill and reputation of Miss Rodeo Idaho, Inc. If I have any concerns about the applicability of this provision, I acknowledge I have been advised to discuss this with a representative of Miss Rodeo Idaho, Inc. prior to signing this form.

- 10) Must not have taken any actions, which in the good faith determination of the Board of MRII will now or in the future likely cause harm or damage to the goodwill or reputation of MRII. This includes the improper use of social media to include but not limited to *Facebook, Twitter, YouTube, Instagram, Snapchat* or any other forms thereof. This also includes but is not limited to inappropriate language, pictures, videos, etc.
- 11) Shall not be a principal (initiating) party in any civil action without prior written notification to the MRII Board of Directors. The MRII Board of Directors reserves the right to disqualify her for title or contract position in cases where the initiation or furtherance of a civil action is contrary to the stated purposes of MRII, or prejudicial to the positive image and effective representation of MRII, Miss Junior Rodeo Idaho, or involves a significant conflict of interest. Shall disclose in writing to MRII any pending civil judgments imposed against her.
- 12) Shall not have been disqualified in prior equine pageant competition for misconduct and/or non-performance nor have forfeited the Miss Junior Rodeo Idaho title.
- 13) I am not a parent of any child and I am not pregnant.
- 14) I am in good health and do not have any health concerns that would prevent me from fully participating in this contest or from serving as Miss Junior Rodeo Idaho if selected.
- 15) I do not use illegal or controlled substances (other than prescription medication and then in only the manner prescribed to me.) I do not abuse alcohol or drugs.

Any contestant not meeting the qualifications set forth above shall be denied the right to compete in the Miss Junior Rodeo Idaho Pageant.

ENTRY PROCEDURES

Each contestant must complete an official MJRI entry application.

The non-refundable Pageant entry fee of \$250.00 must be paid by the sponsoring organization and accompany the entry application. Only a money order or cashier's checks will be accepted.

MRII must receive a complete entry application at the address indicated on the application. **Complete applications postmarked on the closing date provided will be accepted; however**, emailed applications are not considered official. There are no exceptions.

All contestants will be required to sell a minimum of \$200.00 in Pageant Program Ads. Must submit a Pageant Program Ad Form and digital file (jpeg/pdf file) of a print ready ad for each advertisement sold. Refer to Appendix D for more information.

GENERAL PAGEANT

CONDUCT OF CONTESTANTS

- 1. MJRI contestants and titleholders are expected to conduct themselves in an exceptional manner. Unsportsmanlike conduct will not be tolerated. Such conduct could result in the contestant being disqualified and may affect eligibility to compete in future MRII Pageants.
- 2. Harassment and arguing between contestants will not be tolerated.
- 3. A judge may not be approached by a contestant or any individual with the intent to influence or harass. This includes approaching a judge online or through social media. Action of this type will be reported to the MRII Board of Directors and disqualification of that contestant could result.
- 4. The pageant is not officially complete until the coronation is completed.
- 5. Contestants are expected to abide by the MJRI Pageant Contestant Code of Conduct.

CROWNS AND BANNERS

Contestants will not wear a crown at any activities (unless otherwise indicated by dress code). Contestants are required to provide their own banner identifying their sponsor. All banners must be white with black lettering and worn at all pageant activities.

PAGEANT ORIENTATION

Pageant orientation will be held prior to the pageant. Attendance is mandatory. Parents are welcome. Transportation to and from orientation is the sole responsibility of the contestant. The orientation may consist of the following:

- 1. An opportunity to meet the contestants, their parents, and the MRII Board of Directors
- 2. A description of pageant activities with the opportunity to ask questions and receive answers about those activities
- 3. Drawing for the order of a contestant's appearance in all pageant activities

SCHOLARSHIP FUND ADMINISTRATION

Any educational scholarships awarded during the MJRI Pageant are administered by the MRII Board of Directors. Scholarships paid by the Snake River Stampede (if any) or MRII Board of Directors will be paid directly to the hosting university upon the approval of the MRII Board of Directors and the submission of the required documentation. Rules concerning the eligibility and use of these Scholarships are provided in the Application package "Scholarship Letter of Understanding and Rules".

HOUSING & FOOD

Lodging and food during the pageant are the responsibility of the contestant.

CELL PHONE USAGE

The possession of and/or use of electronic devices i.e.: cell phones, laptop computers, and/or any devices with internet capabilities are strictly prohibited by contestants during the competition.

TRANSPORTATION

Contestants in the MJRI Pageant are required to pay their own transportation to and from the site of the pageant. Contestants are required to arrive at MJRI functions on time and appropriately dressed.

CHAPERONES

Contestants are under the supervision of their parents during the contest with the exception of during MJRI contest competition. Once each event is finished, contestants will be returned to parent supervision.

PARENTS, RELATIVES AND FRIENDS

- 1. MRII welcomes and encourages the presence of parents, relatives and friends of the contestants. No boyfriends will be permitted to fraternize with the contestants or to distract them. At the judges' discretion, a contestant may receive point deductions or disqualification for an infraction of this rule.
- 2. At no time will parents, relatives, or friends of the contestants interfere with the pageant committee or MRII Board of Directors.
- 3. If a friend or family member must warm up your horse they will need to pass it to a board member and leave the horsemanship area prior to competition. No interaction with the contestant will be allowed. There will not be any parents, relatives, friends, trainers, etc. allowed in the horsemanship area during the competition. If anyone enters the warm up area or the arena or makes any other contact without permission, their contestant will be given point reductions or disqualification at the judges' discretion.

HORSES

Contestants must provide a horse to be used for horsemanship and provide your own tack. Stalls are available during the competition at the Idaho Horse Park at owners expense. You must bring your own feed and you must purchase all horse bedding directly from the Idaho Horse Park, you are not allowed to bring horse bedding into the park. Any horse being stalled at the Idaho Horse Park must have Proof of Vaccination and a Negative Coggins Test. A friend or family member will be needed to clean, feed and exercise your horse daily. During the week of the pageant, rodeo rules regarding horses and parking are at the discretion of the Snake River Stampede. In the event that your horse becomes sick, lame or unable to perform, contestants may find a replacement horse to use. Contestants must submit veterinary check paperwork verifying inability to perform to the Pageant Director. You are responsible for finding a replacement horse as well as providing both Proof of Vaccination and a current Negative Coggins Test, before the event. If at any time any horse is deemed to be unsafe or unsound it will be removed from any event. All horses used for competition must compete in a bridle. **Stallions are not allowed.**

DRESS

See Appendix A for specific dress requirements for each event.

AWARDS PRESENTATION

All contestants are required to attend the Awards presentation. Contestants will wear full western attire including hat, boots, belt and banner. Should a contestant not attend the Awards presentation, or should a contestant attend without her full western attire, she will automatically forfeit her award(s) and/or scholarship(s).

AWARDS

Awards will be given to high point contestants in the following categories, including: Horsemanship, Speech, Rodeo Knowledge, Personality, Photogenic and Appearance. Specific awards provided in each category may vary from year to year. Additional awards may be provided. The Congeniality Award will be identified by a vote of all contestants.

COMMENTS & SCORESHEETS

Each Contestant will receive a Personal Composite Score Sheet and/or Judges Comment Sheets which will be mailed/emailed to each contestant within 10 business days after the completion of the pageant. If there is a dispute regarding score sheets, they will be sent to the Miss Rodeo America office to approve and verify they are in order.

GRIEVANCES

Grievances should be immediately brought to the attention of the MJRI Pageant Director. All grievances must then be submitted in writing by a contestant and delivered to her chaperone within 3 hours of an incident to be delivered to the MRII Grievance Committee. No other grievances will be acknowledged. The Grievance Committee shall consist of: the MJRI Pageant Director, MRII President, Head Judge and a Contestant Parent selected at orientation. They will utilize a fact-finding process which will include consultation with the contestant(s), the MRII Board of Directors and the other Judges to make a determination. That determination will be considered final. The MJRI Pageant Director and the MRII Board of Directors have full authority over the pageant and any decision they make regarding rules and participation is final.

A grievance cannot be filed based on the outcome of the pageant.

Failure to abide by ALL rules listed within this rule book may result in disqualification or consequences to be determined by the Judges.

Grievance Process for Miss Rodeo Idaho, Inc.

For grievances regarding any processes or incident(s) during the annual Miss Rodeo Idaho Pageant, refer to the Miss Rodeo Idaho Pageant Rule Book.

Grievances regarding organizational business or conduct of the board of directors of Miss Rodeo Idaho, Inc., or individual member(s) of the board must be submitted via this formal complaint process:

- 1. All complaints must be submitted in writing.
- 2. Complaints must include the name, address and daytime phone number of the person filing the complaint. Anonymous complaints will not be accepted or reviewed.
- 3. The complaint should include as much detail about the subject as possible in order for appropriate action to be taken.

Complaints may be addressed to:

- Miss Rodeo Idaho, Inc. President; or
- Miss Rodeo Idaho, Inc. Executive Board

Complaints must be signed and dated, or they will not be accepted.

- If a response to the complaint is desired, the letter must indicate so.
- Any complaints that do not follow the above process will be classified as invalid. All grievance complaints will be brought before the executive board of Miss Rodeo Idaho Inc. A decision will be made by the executive board to act upon, accept or reject the grievance and any appropriate action will be taken.

JUDGING GUIDELINES

Miss Junior Rodeo Idaho contestants are judged in three categories: horsemanship, personality, and appearance. Scores from a contestant's speech, photogenic quality, interview(s), extemporaneous questions, horsemanship/rodeo knowledge questions, introductions, modeling presentation, etc., will be added within those categories. The Miss Junior Rodeo Idaho pageant scoring process will emulate the Miss Rodeo America Pageant Format, with necessary changes approved to reflect the Miss Junior Rodeo Idaho judged events. Please see Appendix C for Contestant's Composite Score Sheet (Scoring Breakdown) and Scoring Criteria. Judging will take precedence over all pageant activities and schedules.

- 1. MRII will provide three to five judges, depending upon the number of contestants.
- 2. Judges are selected for their expertise in all fields of the competition.
- 3. A Head Judge will be chosen.
- 4. Judges may call for impromptu judging of any additional events including but not limited to: interviews, room checks, tack checks etc. Contestants will be under constant observation of judges from orientation throughout the conclusion of pageant.
- 5. Judges may, at their discretion, deduct points if they see trainers coaching contestants from the side during Horsemanship or any part of competition, or if they witness unsportsmanlike conduct at any time.
- 6. Final scores will go directly to the Miss Rodeo Idaho Pageant CPA or auditor. The Head Judge is responsible for the integrity of the score sheets following the end of each event until the envelope can be delivered to a CPA or auditing firm.
- 7. When judging in all divisions has been completed, the auditors will determine which contestants have scored the highest in each category and in the overall scores. The highest overall score will be 2023 MJRI; second highest will be the first runner-up.
- 8. Tie scores in event categories will be broken by referring back to the score of the Head Judge. That score will break the tie. If a tie still remains, the score of the next judge will be used, and so on until the tie is broken.
- 9. A tie score for MJRI and first runner-up will be broken by the Horsemanship scores. The contestant with the highest score in Horsemanship will receive the higher ranking.
- 10. All decisions made by the Judges, MRII Board of Directors and/or the MJRI Grievance committee are final.

JUDGED CATEGORIES/EVENTS

HORSEMANSHIP

The purpose of this judged division is to select the young lady who rates the highest. Areas for consideration are:

- 1. Horsemanship including control of mount and the way she handles any situation
- 2. Balance the ability to sit a saddle
- 3. Positions of hands, feet and seat
- 4. Mounting and dismounting
- 5. Confidence, appearance, and awareness of the audience.

It is not the horse, but the skill, understanding and ability of the contestant that will be judged.

Each contestant will provide their own horse for horsemanship, rodeo presentation rides, and coronation (if needed). See "Horses" under General Guidelines for more details about stalling and caring for contestants' horses. Spurs are optional.

Horsemanship will consist of one horsemanship pattern on the contestant's own horse. The pattern selected is pattern #2 at the end of the rulebook. At the Judges' discretion, the patterns may be altered. Contestants may also be required to participate in an equitation class. Any changes and/or alterations to the horsemanship patterns will be announced to the contestants before the Horsemanship competition begins. The pattern will be demonstrated by the reigning MJRI. The contestant's overall equitation, poise, confidence, appearance, and position throughout both rounds will be evaluated. Contestants and their advisors who seek additional guidance regarding their horsemanship presentation, are referred to the AQHA Rulebook Section SHW434 'Presentation and Position of Exhibitor' Note: (Please bring a flag boot with you.)

Judges may, at their discretion, deduct points or disqualify from competition any contestant if they see trainers, family members, or friends coaching contestants from the side.

PERSONALITY

The purpose of this division is to select the young lady:

- 1. Who exudes intelligence, can maintain an educated conversation in rodeo, agriculture, current events as well as show a genuine concern and interest in other people, in the pageant,
- 2. Who radiates self confidence without making an issue out of it and can perform under pressure
- 3. Who is sincere and maintains a high moral standard her personality is reflected in her style of attire, her overall appearance, posture, presence whether it be from horseback in an arena, on television or before an audience.
- 4. Also considering her sense of humor, showmanship, ambition, desire and enthusiasm, while maintaining a positive outlook on life,
- 5. Making promptness of pageant schedule a priority,
- 6. Being mindful in public appearances to speak to an audience with facts and interesting information about their hometown, and their state,
- 7. Contestants will be expected to answer questions that have been prepared in advance, in at least one of the public appearances. The questions should exemplify the contestants ability to think on their feet with a sense of wisdom and imagination.

APPEARANCE

The purpose of this judged division is to select the young lady who reflects poise and dignity and who takes pride in their appearance through neatness and cleanliness in every detail such as complexion, cosmetics, hands, fingernails, hair, and western apparel; poise which includes posture and lady like behavior; photogenic quality. A thorough demonstration and knowledge of proper western attire which may include: color coordination, proper fit, boots, crease and hat shape; dresses, skirts, and blouses should reflect a western image where evening gowns and/cocktail type dresses are not permitted; appropriate dress for all occasions. Contestants may choose to wear a dress or outfit more than once. Contestants are expected to appear in full western attire at all times unless otherwise specified. This includes Wrangler® pants or jeans, dresses, skirts, blouses, jackets, hats, boots, belt and banner with proper knowledge of current trends in western wear industry.

PUBLIC SPEAKING

Speech- Each contestant is required to give a two (2) minute speech. The speech topic is:

As Miss Junior Rodeo Idaho, how will I serve and promote the sport of Rodeo?

No props will be allowed. All speeches will be timed, and the judges will be given the length of each contestant's speech. The purpose of this judged division is to select the contestant who rates highest on content; delivery, including use of microphone, enunciation and grammar; appearance, including poise; self-assurance, including personality, projection to the audience, and eye contact; organization and subject relevance to required topic.

MODELING

Contestants will participate in at least one modeling pattern. Areas for consideration are: personality, appearance, creativity, initiative/flair, stage presence, proper presentation, and self-confidence.

PRIVATE INTERVIEWS

Each contestant will be interviewed privately once by the judges for a minimum of 10 minutes and not to exceed 15 minutes each time. Judging criteria includes:

- 1. Correct answers to questions related to knowledge of the pageant, knowledge of the ProRodeo World including PRCA and WPRA/PWRA (including current standings, history & organization), rodeo terminology, explanation of rodeo events, equine knowledge (including tack, horse care, feeding, diseases, anatomy, etc.) & current events.
- 2. Appearance
- 3. Personality

WRITTEN TEST

Contestants will be required to take a written test, which will consist of questions relating to the sport of rodeo, PRCA, WPRA, the Snake River Stampede and equine knowledge, etc. Tests will be scored with the highest score winning. These scores will count in the total score; tests will be presented to the judges for their reference.

PHOTOGENIC

The judges will score photogenic ability by the 8" x 10" vertical head and shoulders photograph that is submitted with Contestant Application. Photogenic Quality may include: Overall appearance, expression-attitude, choice of colors, personality, ability to work with a photographer and eye contact with camera.

PAGEANT PROGRAM AD SALES

Each contestant will be required to sell a minimum of \$200.00 worth of Pageant Program Ads. No points will be given for this category. After the minimum requirement is met, the Contestant will receive 20% of additional sales. Please see Appendix D for Pageant Program Ad Criteria and Information.

SUBJECT TO CHANGE

The Miss Junior Rodeo Idaho Pageant Rulebook is subject to be revised prior to June 1st. All contestants will receive notification of any changes. It is recommended to stay in contact with the MRII Pageant Director so that all information and possible changes are easily shared.

APPENDIX A DRESS CODE FOR PAGEANT EVENTS

Photogenic: Outfit of your choice, 8x10 color head- and-shoulders photo. Hat

required (no crown or banner)

Orientation/ Wrangler® pants product required with shirt, vest, or jacket.

Horsemanship Interview:

Personality Wrangler® pant product or skirt (not required to be Wrangler).

Interview: Vest or jacket required.

Fashion Show: Opening outfit: A fashion forward stage outfit that expresses

individual and western style. It can be pants, skirt or a casual dress. It does not need to be formal but does need to be something you can move freely in. Additional outfits will be

provided to model in.

Speech: Speech outfit: modern, contemporary dress/skirt with blouse

and/or jacket/vest, boots, cowboy hat, belt and buckle.

Horsemanship:

Wrangler® pants product; form-fitting blouse or shirt with long

sleeves, any color. (No vests or jackets)

MJRI Coronation: Western Elegance-Dress or skirt with blouse and/or jacket/vest,

boots, cowboy hat, belt, and buckle

^{**} Penalty for violation of the wardrobe requirements will be at the discretion of the judges.


Appendix B

Each Contestant will compete in one go-round of the horsemanship competition. Contestants will draw for the order in which they compete. Contestants will ride their own horse completing pattern 2 (see attached) Spurs are optional.

** Note: Please bring a flag boot with you to competition. **

All patterns will be executed as written, not as drawn.



Horsemanship Pattern 2:

- 1. Circle the arena, on the left lead, at an extended lope.
- 2. Guide left and lope down the center of the arena with moderate speed.
- 3. Pass the center of the arena, stop and back to the center.
- Execute a 3/4 turn to the right and lope a circle, to the right, with moderate speed.
- 5. Change leads and lope a circle, to the left, with moderate speed. After completing the circle, continue loping on the left lead toward the end of the arena.
- 6. Stop and pause to show completion of pattern.

The duration will be from July 18th, 2023 until the passing of the crown and Miss Junior Rodeo Idaho Contract Signing at a date, time, location which will be determined by the current Board of Directors. The purpose of this title is to allow for the Lady-In-Waiting to:

- 1. Make scheduled appearances that are in the best interest and at the direction of MRII Board of Directors, and the Snake River Stampede.
- a) These will be very specific appearances only approved and scheduled by the current Board of Directors. No other appearances as Miss Junior Rodeo Idaho Lady-In-Waiting will be allowed and every appearance will be made with the utmost respect to the reigning Miss Junior Rodeo Idaho, and this includes all social media and online presence.
- b) Official appearances will be made in official Miss Junior Rodeo Idaho Lady-In-Waiting Banner, Miss Junior Rodeo Idaho Traveling Belt Buckle, and appropriate attire as requested by the MRII Board of Directors
- 2. Miss Junior Rodeo Idaho Lady-In-Waiting will be able to approach sponsors and raise funds at the discretion of MRII.
- 3. Miss Junior Rodeo Idaho Lady-In-Waiting will not approach any Snake River Stampede Rodeo or Stampede for the Cure Sponsors without written permission from the MRII Board of Directors, SRS and SFTC Board of Directors. A list will be provided with the LIW Contract.
- 4. All expenses will be that of the Lady-In-Waiting, which may be reimbursed once funds are available according to contract reimbursement guidelines.
- 5. If the Lady-In-Waiting has a current sponsor and/or title which she needs to further represent, she will be able to continue to represent said title at non-official appearances i.e. rodeos, parades, local contests, and community events as her sponsor title and not as Miss Junior Rodeo Idaho 2024, MJRI- Elect, 2024 Miss Junior Rodeo Idaho Lady-In-Waiting.
- 6. The Lady-In-Waiting will recognize that this experience is a costly endeavor with a minimum expense of \$2,000.00 for basic travel and appearances.
